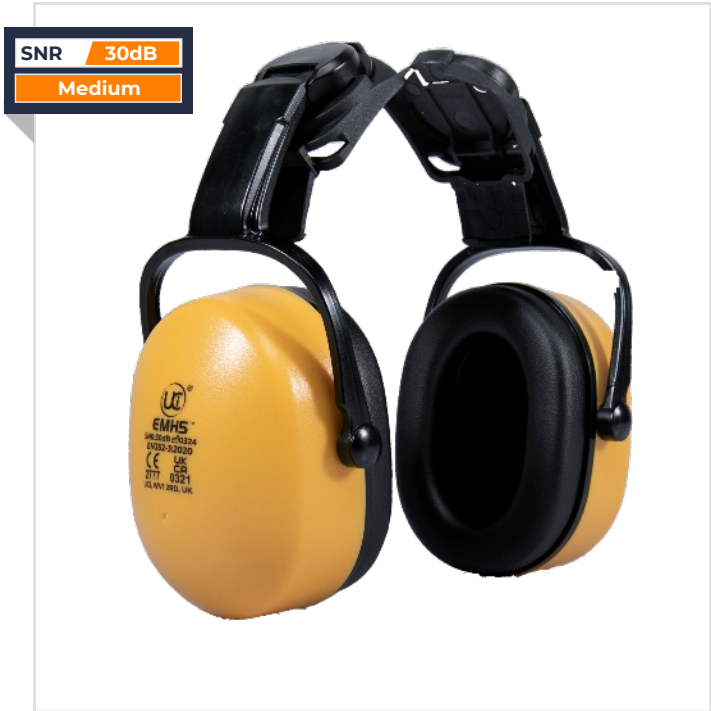

FURTHER INFORMATION

STORAGE / TRANSPORT: Keep away from direct sunlight; store in a cool dry place. During transportation, ensure the product is well packaged to prevent damage. Store in their original packaging.

PRECAUTIONS BEFORE USE: It is very important that the fitting instructions and recommendations are adhered to. If not the protection offered will be seriously impaired and serious injury may result. Further information should be sought from the manufacturer. The enclosed product information sheet should be read before use. Please inspect the earmuff before use and discard if damaged in anyway whatsoever.

RECOMMENDATION: The ear muffs must be worn all the time the wearer is exposed to noise. Removing the ear muffs for even a small amount of time could result in serious injury. Keep away from infants and small children. The parts of the ear muff in contact with the skin should be disinfected periodically (at least every 3 months) with a suitable disinfectant solution.

INSTRUCTIONS FOR USE:

1. Brush aside any excess hair and remove ear jewellery that may affect the ear muffs acoustic seal.
2. Extend the headband to maximum open position and place the cups over the ears with the headband passing over the top of the head.
3. Settle the headband in position on top of the head while adjusting the height of the ear cups until they feel comfortable and fully cover the ears. Ensure the headband rests on top of the head.
4. Put the earmuffs on before exposing yourself to noise and wear them for the whole period of noise exposure.
